## NASIC Alumni Association Calendar Year (CY) 2014 Annual Financial Report

## **<u>NASIC HIGHLIGHTS</u>** (Provided by Mr. Larry Benson)

Mr. Curtis A. Rowland, acting Chief Scientist since Mr. Gary O'Connell retired on 1 April, was selected in September to be the seventh senior executive to hold that position since Foreign Technology Division (FTD) was established nearly 60 years ago. Mr. Rowland came to FTD in 1982 following graduation from Wright State University, beginning his career as an aerodynamic missile systems analyst. Subsequently, he held a wide range of responsible intelligence production and resource management positions at virtually every organizational level. He was appointed as a Defense Intelligence Senior Leader (DISL) in 2004 and served in four Technical Director positions during the intervening 10 years, most recently in the Geospatial and Signature Intelligence Group (GS). In addition to serving on numerous national level intelligence community boards, working groups and committees, he was awarded the Presidential Rank Award as a Meritorious Senior Professional in 2009. From the alumni perspective, Mr. Rowland has been a consistently loyal supporter, to include having spearheaded the establishment of the NASIC Wall of Honor. He is most deserving of our very best wishes as he leads NASIC into a constantly evolving and challenging era requiring innovation and dedicated leadership.

There remain two senior executive positions to be filled. Mr. Keith Hoffman was moved from the Air and Cyberspace Intelligence Group (AC) to replace Mr. Rowland in GS. The retirement of Mr. Lee Fuell created a vacancy in the Space, Missiles and Force Intelligence Group (SM). Upon completion of these fill actions, NASIC will have experienced a complete turnover of its senior executives in a relatively short timeframe, probably a little disconcerting to many of the alumni who still think of the retired generation as "just kids."

As predicted in the last newsletter, NASIC has been significantly impacted by the most recent Air Force reorganization. The AF Intelligence, Surveillance and Reconnaissance Agency (AFISRA), current iteration of the San Antonio-based parent command dating from 1991, has been designated as 25th Air Force under the Air Combat Command (ACC). Based upon NASIC's status as a principally national resourced organization, it was decided it should be moved directly under HQ USAF as a Field Operating Agency (FOA) vice moving with the other AFISRA assets to stand-up the new operationally focused 25th Air Force. Congressional concern regarding the apparent additional organizational levels between NASIC and its national program managers and customers was a primary factor. Few are still around to remember, but this is a case of "full circle" as NASIC predecessors were direct reporting units to Air Staff in the 50s prior to the establishment of FTD under Air Force Systems Command. NASIC's relationship to its functional managers, Defense Intelligence Agency (DIA) and National Geospatial-Intelligence Agency (NGA) will remain unchanged.

Speaking of interest from Capitol Hill, the last few months have seen a significant upswing in visits from members of Congress. The Ohio delegation role and corporate Dayton interest in showcasing the capabilities, potential and ongoing contributions of NASIC as a major national intelligence asset have been a dominant factor in sustaining resources at a time of growing concern for the future. This is not to imply that there will not be tough times ahead, but is an indicator that the communications are in place to ensure that NASIC capabilities remain at the forefront during intelligence budget and manpower considerations. The corporate role is especially significant as NASIC contracts have attracted interest from key defense contractors nationwide, adding proponents for the NASIC mission while contributing significantly to the commercial intelligence capabilities resident in Dayton.

As the Holiday season approaches, there will be several activities which alumni may find of interest. In addition to the usual Christmas events, an open house is planned. The NASIC Angel Tree program is about to shift into high gear. This activity now provides Christmas for 300-500 children in the Dayton area, kids who would otherwise go without. Some of you will remember that this program, now considered a model for Wright-Patterson and community agencies, began with a FTD Wives Club effort to support 2-3 families back in the late 80s. Wives clubs are gone but their legacy lives on with the super dedicated leadership of a small group of NASIC personnel and contributory support from a huge segment of the workforce. Please watch your e-mail for notes on these and other items of interest as the holidays approach.

Francis Arcier Scholarship Program recognizes: (1) the children and grandchildren of current National Air and Space Intelligence Center (NASIC) employees (active duty military and civilian employees), and (2) children and grandchildren of former employees (Alumni) of NASIC or predecessor organizations.

Applicants must be high school seniors who plan to attend college or college students in an undergraduate program. The scholarship provides a monetary award to the individual(s) who is (are) judged to have demonstrated superior personal and academic qualities.

Certain eligibility limitations are described in the attachments to this package. An impartial board comprised of Alumni Association members will evaluate each application. Applicants are evaluated solely on the basis of personal and academic qualities as indicated by scholastic performance, participation and leadership in extracurricular activities, recommendations by teachers (professors) or community leaders, and applicant's interests and long- range goals. Please follow the instructions and submit the package by the deadline given.

Keep in mind that the review committee will be evaluating applicants on the basis of their application package; therefore, overall appearance and completeness are likely to affect the final rating. #### AWARD

#### ELIGIBILITY


**Emily Austyn Albrecht**
