#### 2. Current NASICAA Membership Bylaws and Categories.

#### A. Current Membership

- a. Eligibility:
  - Current Membership is open to persons who are serving or who have served in a military, civilian or contractor capacity at NASIC.
  - With the approval of the Executive Board, Current Membership is also offered to others who are interested in promoting the purposes of the NASICAA.
- b. Criteria: Current Members are in good standing if their dues are paid for the current calendar year or for the current calendar year plus any number of years into the future.
- c. Privileges:
  - Current Members may vote on issues submitted to the membership at large.
  - Current Members may be elected to any NASICAA officer or staff position.
  - Current Members will receive invitations to Alumni Association and NASIC events; newsletters; rosters and roster updates; Alumni Association news updates; and other notices throughout the year via email (if available to the member) or USPS (if the member does not use email).

#### **B.** Lifetime Membership

- a. Eligibility
  - All Members: An optional Lifetime Membership is available to Current Members at the following rates:
- Under 50: \$250.00

- 50-64: \$150.00
- 65-74: \$100.00
- 75-80: \$50.00
- Over 80: Free
  - Honorary Lifetime Members: As conferred on a case-by-case basis by the Executive Board.
- b. Privileges:
  - Lifetime Members may vote on issues submitted to the membership at large.
  - Lifetime Members may be elected to any NASICAA officer or staff position.
  - Lifetime Members will receive invitations to Alumni Association and NASIC events; newsletters; rosters and roster updates; Alumni Association news updates; and other notices throughout the year via email (if available to the member) or USPS (if the member does not use email).

#### C. Reserve Membership

- a. Eligibility: Same as Current Members.
- b. Criteria: Any Member whose dues are overdue, but are current within three calendar years (including the current calendar year).
- c. Privileges:
  - Reserve Members will continue to receive invitations to Alumni Association events, newsletters, rosters and roster updates, and Alumni Association notices via email or USPS, as appropriate.
  - Reserve Members may not vote or hold office.

#### D. Inactive Membership

- a. Eligibility: Same as Current Members.
- b. Criteria: Any Member whose dues are overdue and have not been paid for more than the three past calendar years (including the current calendar year).
- c. Privileges:
  - Inactive Members will not receive newsletters, rosters and roster updates and Alumni Association notices via USPS. Since email distribution of such items incurs no financial cost to NASICAA, email distribution of these items may be continued to Inactive Members at the Membership VP's discretion.
  - Inactive Members may not vote or hold office.
- d. Dues Reminders:
  - Once members become "Inactive," the Membership VP will make an effort to contact each Inactive Member and to encourage them to re-activate their membership.
  - This contact will occur periodically for a period of one year from the time the member became inactive.
  - If no contact can be made for one year after the member becomes inactive, the member will be dropped from the membership database.

#### E. Corporate Membership

- a. Eligibility: Extended by the Executive Board to organizations that exhibit an interest in promoting the welfare of NASIC and in supporting the purposes of the NASICAA.
- b. Privileges:
- c. Corporate members may not vote nor hold office.
- d. Designated Corporate Member representatives, selected by the Executive Board, will receive invitations to Alumni Association events and other notices of interest throughout the year via email.

## 2017 A. Francis Arcier Scholarship Program

The A. Francis Arcier Scholarship Program recognizes: (1) the children and grandchildren of current National Air and Space Intelligence Center (NASIC) employees (active duty military and civilian employees), and (2) children and grandchildren of former employees (Alumni) of NASIC or predecessor organizations. Applicants must be high school seniors who plan to attend college or college students in an undergraduate program. The scholarship provides a monetary award to the individual(s) who is (are) judged to have demonstrated superior personal and academic qualities. Certain eligibility limitations are described in the attachments to this package.

An impartial board comprised of Alumni Association members will evaluate each application. Applicants are evaluated solely on the basis of personal and academic qualities as indicated by scholastic performance, participation and leadership in extracurricular activities, recommendations by teachers (professors) or community leaders, and applicant's interests and long-range goals. Please follow the instructions and submit the package by the deadline given.

The 2016 scholarships were awarded from the \$11,000 raised by the NASIC Alumni Association. Our goal in 2017 is to match or exceed last year funds. However, that cannot be accomplished simply through golf tournaments but also from a number of fund raising efforts, and we are looking into new ways of raising funds for 2017.

A number of members contributed to the scholarship fund during 2016. <u>Individual contributions can be made by Alumni members, and the scholarship contribution is tax deductible.</u> If you are interested, please send checks to NASIC Alumni Association in care of;


The complete application package must be postmarked by Friday, 3 March 2017.
























































## 2016 NASIC Alumni Association Warrior Support Open

## NASIC Alumni Association Annual Meeting



The NASIC Alumni Association held its annual meeting for all members on 28 October 2016 at the WPAFB Twin Base Golf Club House, Jones Room, 0800-1630. Attendance included 39 members and 10 guests. Wayne Wolfe, NASICAA VP presided **Speakers**:

- Rob Young, NASIC Historian and Michelle Martz, NASIC Public Affairs Office: "2017 Centennial NASIC and its Predecessors at 100 Years." Suggestion was made to involve Roy Brown, last surviving Watson Whizzer.
- Dr Carl Brenner, Col, USAF (Ret): NASIC 2023 Integrates NASIC with AFISR 2013; NASIC now DRU to Hq USAF/A2
- Col Trisha Sexton, Col, USAF; NASIC Vice Commander discussed: the Centennial; summarized how a number of current
  NASIC leaders had prior NASIC assignments; growth is ~100/year since 2000; new NASIC facility is much needed but may be
  10 years out due to current funding; the Knowledge Wall is an effort to focus on the most significant issues; 636
  distinguished visitors/year; Congressman Turner is a very strong NASIC supporter.
- Wolfgang Samuel, Col, USAF (Ret): This is Wolf's 2nd year in a row to address our meeting. Wolf and his wife Joan come to Dayton from their home in the Washington DC area. Last year Wolf spoke primarily about his life and trials as a young German boy near the end of WWII, faced with the impending arrival of the Red Army. This year Wolf traced his life's journey from dreaming as a young German boy living in abject poverty in a refugee camp after WWII of one day flying with "those American pilots in those big planes" that were flying over him during the Berlin Airlift to his 30-year career as a USAF navigator flying combat missions on a number of a/c, including the RB-47 and B-66.

## Wall of Honor Nomination

#### - ELIGIBILITY CRITERIA:

- -- Any former civilian or military employee whose career with NASIC deserves recognition is eligible to be selected for placement on the Wall of Honor.
- -- A "former" employee is defined as any individual who separated or retired from US Government service before 1 Jul of the current award period.
- -- Normally, for the purposes of this award, a career would be at least 15 years of federal service, with at least 30 months spent at NASIC.
- -- Any individual previously selected as a Watson Award winner was automatically placed on the NASIC Wall of Honor upon their separation or retirement from US Government service.

### NASIC Centennial

This year is the 100th anniversary of NASIC & its predecessor organizations devoted to technical intelligence at Wright-Patterson AFB. There will be monthly presentations/events dedicated to past accomplishments & the people who contributed. These began in January with a presentation by Historian Rob Young covering the first 50 years. February's program will cover the 50 years bringing the organization to current times. The NASICAA has been asked to participate; however, the follow-on program is still being organized. Further details will be forthcoming via our regular news updates. Tentatively, there will be an event in early to middle summer headlined by the former Director of National Intelligence, LtGen (Ret) James Clapper.
